# EDUCATIONAL PACT OF CO-RESPONSIBILITY S.Y. 2023 – 2024

#### **WHEREAS**

- the C.P.I.A "G. Foti" of Viterbo, a school institution responsible for organising educational activities aimed at adults and young adults, believes:
  - that the school is a place of civil and cultural growth for every person;
- that the school has not only the duty to help its students develop key competencies, but also to convey values, in order to become active citizens who have a sense of identity, belonging and responsibility;
- that mutual respect and the sharing of rules with its various users, are indispensable elements in establishing a relationship of mutual trust for the achievement of its educational objectives;
- that its educational function can only be carried out effectively by establishing cooperation among all the actors that constitute the school community, including families and/or educational communities for minors, while observing their respective roles;

### our institution proposes

the following Educational Pact of Co-responsibility, which defines the commitments, rights and duties that the relevant

parties of the school are required to observe in a mutually respectful and responsible manner, in order to ensure its full implementation.

#### The C.P.I.A "G. Foti" of Viterbo undertakes to:

- create a serene and welcoming environment for adults and young adults returning to education and help orientate their decisions regarding the most suitable school path, with consideration of the skills already acquired in their personal life, both in formal, informal and non-formal contexts;
- provide a cultural education that is open towards a plurality of ideas, respecting each student, encouraging full inclusion, preserving their culture and promoting welcoming initiatives;
- create and implement positive relationships based upon dialogue and mutual respect, working on interpersonal relations, especially when concerning minors;
  - offer a favourable environment for the integral growth of every person;
  - respect the methods, times and rhythms that are specific to each person, within the learning/teaching dynamic;
- implement the disciplinary curricula by providing, when necessary, remedial and reinforcement activities;
- promote the teaching of correct lifestyles, in order to foster integration into society and in the professional contexts, both of Italian and of foreign students;
- enforce the codes of conduct, the rules and the prohibitions of the School Regulations;
- take appropriate disciplinary measures in the event of infringements, in accordance with the Disciplinary Regulations for students, which is published on the school's official website;
- promote the development of a network system among the school, the families, the services and the territory, with a view to a coherent and integrated educational support;
  - ensure maximum transparency in assessments and communications, while respecting privacy;
- maintain constant contact with the families or the communities of under-age students, in relation to their educational growth.

## The student undertakes to:

- comply with the rules of behaviour and the prohibitions specified in the School Regulations;
- become aware of rights and duties, by respecting the school and considering it as a whole of people, spaces and equipment;
- maintain an appropriate, respectful and collaborative attitude towards other students, teachers and the entire school staff;
  - accept and respect people, considering each person as culturally different;
  - follow the course of study with responsibility, taking an active part in the educational dialogue;
- take note of and share the objectives of any disciplinary measures aimed at reinforcing a sense of responsibility and restoring correct relations within the school community;
- attend lessons with the utmost regularity, punctuality and respect of the school timetable, on the basis of the Educational Pact that will be signed with this School Institution.

## The family/educational community (for minor students) undertakes to:

- ensure the regularity of the enrolled student with regard to the vaccination obligations provided for by the regulations in force;

- collaborate with the school in respecting the rules, establishing a positive attitude of dialogue and mutual cooperation both with the teachers and the entire staff;
- justify absences in paper form or by using the special function provided by the school's Electronic Register, using the "Parent/Guardian profile" to access the register; whose access credentials they guarantee to keep confidential, without ever providing them to third parties, even occasionally, and to encourage in every way the assiduous attendance of their children/minor students at lessons;
- responding promptly to the school's communications to face any issues relating to behavioural or learning concerns;
- support warnings and possible sanctions aimed at reinforcing a sense of responsability and restoring correct relations within the school community;
  - immediately notify the school of any changes concerning address, availability and host community.
